SUNDAY, 9TH DECEMBER 1962

Preliminary inspection of 18 acre site comprising part of Bottoms Farm Silverdale by-George S Evenden Chairman, Local Association

Inspection group gathered at Carnforth Fire Station at 2.00 p.m. and proceeded by car to Silverdale. The weather was very changeable, cloudy with sunny periods, cold.

The site was entered from The Row were the cars were parked; Mr Jolly acting as guide as he had inspected site previously.

We proceeded round the perimeter of the site as follows:- entered by limestone chipped path - 6 feet wide, solid, this opens into a natural track which proceeds uphill towards a summit. Solid path, although wet previous day. It was noticed, with dismay, that woodcutters had commenced operations at this point - fence posts.

After 200 yards first clearing entered - this is focal point of campsite. Site is well pathed and they converge on this clearing. Possible site for H.Q. block ?

We wended our way through the undergrowth to arrive eventually at the other large clearing. Deep grass - main camp site; passed within 200 yards of Stankelt Road at this point.

Turned along gorge here, varying between approx. 20 - 40 feet in depth. <u>Very</u> thickly wooded chasm. Small stream ? at base of cliff. Public footpath skirts edge of site here. Back to first clearing.

Wood - Site is amply covered by trees, majority deciduous. Underbrush thick in patches. **Trees** - Birch, beech, oak, yew and hawthorn in quantity. Holly, ash etc. in small quantity. **Geology** - Limestone in large quantity, frequently exposed to view. Characterised by limestone pavement Little other rock in evidence.

Opinion:

Scouters present expressed their profound satisfaction at all the amenities present and also the sylvan beauty of the location.

Most suitable for camping. It was the general opinion that no better site would be found, on the market, within 10 miles of Morecambe.

This opinion was expressed to the LA members who decided to probe a little further into the matter..

7TH JANUARY 1963

Executive Meeting - 6th Morecambe & Heysham Scout HQ DC presented report on site. Go ahead given by Local Association.

Notes after writing

1. Per inspection - site impractical as agricultural land.

2. Per local knowledge - planning permission refused. (Area frozen by Town and Country Planning as "green belt")

4TH FEBRUARY 1963

Executive Meeting.

Further details re site obtained. Mr Eric Lowe had contacted Bannister Bates & Son to act as solicitors in purchase.

Vendors solicitors had been contacted and also plans scrutinised and price suggested **£20 0s 0d per acre**. **£400 for whole.**

Mr Jolly to approach vendor to agree final details of purchase.

DC had suggested early settlement as Association wants to get to grips with site clearance at earliest opportunity.

7TH MARCH 1963

Scouters Meeting

Owners of land had proved reticent in accepting offer of £400. Mr Jolly was unable to vary their view.

Mr Lowe visited owner this morning with an offer of **£750.** Owner stated that she would consider offer.

Later agreed by letter to accept offer as stated.

Contract to be drawn up by vendor's solicitors and completion expected by end of month.
