# LONSDALE DISTRICT TRUSTEE BOARD



### Purpose

This information sheet has been compiled to provide background information for potential members of the District Trustee Board.

## **Essential Information**

Lonsdale District Scout Council is a registered charity (1027167) and members of the District Trustee Board are the Charity's Trustees.

The District Trustee Board reports annually to the District Scout Council's Annual General Meeting (AGM) and as such it is the Council's 'executive body' (and is thus answerable for its actions to the Council).

Membership of the Trustee Board can be summarised as:

- **Ex-officio Members** those holding specific appointments within the District (such as District Commissioner, District Youth Commissioner, etc).
- **Elected Members** those elected by the Council at its AGM.
- Nominated Members those nominated by the District Commissioner and approved by the Council at its AGM.
- **Co-opted Members** those appointed by the Trustee Board after the Council's AGM.

Note that no Trustee can be under the age of 18 years.

To assist the Trustee Board in fulfilling its responsibilities, a number of sub-Committees have been formed:

- Activity Centres Management Board
- Appointments Advisory Committee
- Awards Advisory Committee
- Finance sub-Committee
- 14-25 Finance and Support Group

Currently the Trustee Board meets five times a year - approximately every two months between September and May.

It would be our aspiration that each member of the District Trustee Board makes a positive commitment to attend each meeting and is involved as a full and active participant in the work of the Trustee Board (plus any sub-Committee they may be appointed to).

### **Responsibilities of the Trustee Board**

The Trustee Board is a team of volunteers who work together, as charity Trustees, to make sure the Scouts is run safely and legally. At the heart of their role is to focus on strategy, performance and assurance.

The purpose of the Trustee Board is given in Policy, Organisation and Rules 5.4.4. Our five established sub-Committees give an indication of how we spilt the detail of the work of the Trustee Board. Of necessity, finance is a key responsibility - including support for our programme and the operation of our two Activity Centres (at Littledale and SilverHelme).

Why join the District Trustee Board?

Essentially you will contribute to shaping and developing Scouting in Lonsdale thus enabling more young people develop their potential.

Also, you will be acquiring experience, skills and knowledge you might not otherwise have the opportunity to gain - which may be beneficial for your career development or future volunteering.

### Trustee Search

Our Trustee search is in two categories:

**1. Elected Members** – up to six to be elected (of which one has to be a young person in the age range 18 to 25 years - ideally not reaching their 25<sup>th</sup>

birthday before 1 September 2024). As with all Trustees, we seek those who have the background, specific skills and knowledge (either professionally or from their volunteering) to positively contribute to the work of the District Trustee Board.

The nomination and election process will be defined in due course.

Elected members serve for one year; many have served longer (having been re-elected on a number of occasions).

2. Nominated Members - we might also be seeking to recruit those with specific skills or knowledge (particularly for appointment as chairs of our sub-Committees). There is no formalised process to identify potential Nominated Members [of the Trustee Board]. Appointments are made by a nomination made to the District Commissioner (at the AGM). If you feel that you have skills which equip you for a more specific role then please contact either the District Commissioner or District Chair (contact e-mails at the foot of the next column).

Nominated members serve for one year, but to provide continuity, appointments may be extended, annually for a number of years (at the discretion of the District Commissioner and the AGM).

### **Trustee Skills**

We are looking for people who:

- can make a positive contribution to the work of the Trustee Board (as such a detailed knowledge of Scouting is desirable but not essential).
- have time to prepare for each meeting of the Trustee Board (we aim to publish the agenda and supporting papers the week before the scheduled meeting).
- make a positive commitment to attend each meeting of the Trustee Board.
- listen objectively to inputs, contribute to discussions and make decisions objectively.

In making any decision, Trustees have to be certain that they:

- act in the charity's best interests.
- manage the charity's resources responsibly.
- act with reasonable care and skill.

The question is: what will be best for Lonsdale Scouts (and not their own or others' interests).

### Induction

In the autumn we will provide an induction session to introduce everyone to the role as a Trustee (and provide background information).

### **Trustee Declaration**

The District Trustee Board has decided that all Trustees will annually sign a Trustee Declaration. This asks the signatory to confirm there are no factors that prohibit appointment as a Trustee (as set out by the Charity Commission).
